In the reference 9<sup>th</sup> read above, Provisional recognition hereby accorded for Classes I to VII (EM) to the management of EDIFY ENGLISH MEDIUM SCHOOL, H.No.8-122, NH-44, Laxmipuram(V), Kallur (M), Kurnool Dist for one year i.e. 2021-22 and further informed that, the extension of recognition period i.e. 2022-23 to 2023-24 will be considered on submission fire NOC by the Management through Inspecting officer.

Accordingly, the management has submitted extension recognition proposals through the Mandal Educational Officer, Kallur vide reference 10<sup>th</sup> read above, duly enclosing the FIRE NOC Certificate up to 05 years as per Lr.Rc.No.3087/Non-HRB/ST/KNL/2021, dt:20.10.2021 of the Director General, State Disaster Response and Fire Services, A.P., Vijayawada and further requested to grant renewal of recognition for another 04 years from :2021-2022 to 2024-2025.

After careful examination of the extension recognition proposals from the inspection report of the inspecting officer in the reference 10<sup>th</sup> read above, under rule 3(i) (a) of GO 1<sup>st</sup> read above, Provisional Recognition for classes I to VII (EM) extended for academic years from : 2022-23 to 2023-24 in respect of EDIFY ENGLISH MEDIUM SCHOOL, H.No.8-122, NH-44, Laxmipuram (V), Kallur (M), Kurnool Dist Subject to fulfilment of the following conditions.

1. That the institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
2. That the school timing vacations and mid - term holidays shall be followed as prescribed by Government from time to time.
3. That the qualified staff within the age limits prescribed by Government employees shall be appointed with the management own funds as per staff pattern.
4. That the results of institution shall be satisfactory every year.
5. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
6. That the list of Governing Body shall be furnished to the District Educational Officer every year.
7. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
8. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this orders shall be complied with
9. That the school shall not be remained closed without giving notice both to the parents / District Educational Officer, and competent authority at least six months before.
10. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
11. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expiry of the Provisional recognition now granted.

12. That the society shall provide fire safety measures in the school as per the No objection certificate. Advice of the Fire Services Department authorities immediately.

13. The management is informed that no thatched roof accommodation is allowed to run the school.
14. Proper and adequate sanitation facility shall be provided for students especially for girl students.
15. The school shall follow the traffic and safety measures shall be taken for children within the school campus and also near the school premises.
16. The school shall follow the traffic and safety guidelines indicated by the police and fire services, Departments.
17. The parent teachers associations meeting should be conducted to sensitize the parents on the safety of the children and also for the various health concerns of their children.
18. The school shall have first aid kit and the teachers shall be trained in first aid.
19. The Correspondent of the concerned school is hereby informed to file an affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time without fail.
20. That the management shall obtain and submit the structural soundness certificate every year before Re-opening of the school for the academic year.
21. That the management shall take every responsibility for the timely, safe and comfortable mobility of the school Children from the residences to School and vice versa.
22. That the School Van if any should be ensured road worthy for the transportation mobility of schoolchildren.
23. That the school van should be free from all taxes due and should be maintained with regular checks by authorized mechanics periodically / as and when required without causing any sort of dislocation for the school children opting the van facility.
24. That the management shall engage skilled experienced and authorized drivers having good health and good vision for the school vans if any.
25. That the management shall insure the vehicle and safety grills be provided to all the windows of the vehicles if any without fail.
26. That management shall ensure the accounts of the school audited by an authorized chartered accountant every year and submit.
27. The management shall have to follow the rules and guidelines issued to Go.Ms.No91, Edn., Dt.06.08.2009 regarding fee structure in private Schools.
28. The management shall have to follow the G.O. Ms.No.01 and subsequent G.Os / memos issued from time to time without any deviation.
29. That the management shall not run any Pre-primary classes other than those now permitted and also shall not run hostel.
30. That the management shall ensure all the children studying in their school shall be brought in to child info without fail.
31. That the Management shall maintain / provide required fire extinguishers in the school premises.
32. That the Management shall ensure for the regular healthcheck-up of the school children periodically and shall coordinate with the Medical & Health Department authorities concerned without fail.
33. Structural soundness Certificate and Sanitary Certificate should be obtained for the renewal period.
34. The MEO Kallur shall ensure that all conditions are properly complied with by the Management from time to time.
35. Any deviation of the norms / guidelines issued from time to time will be viewed seriously.

6. That the results of institution shall be satisfactory every year.
7. That the records/accounts shall be furnished to the District Educational Officer every year 31<sup>st</sup> May at latest.  
The Management is informed that as per G.O.Ms.No.1 Education dated: 01-01-1994, the fee collection from the students shall be allocated as to meet the following requirements: -
  - a. 50% of the fees collected shall be earmarked towards payment of salaries to the staff.
  - b. 15% of fees collected shall be utilized for the maintenance of the institutions towards expenditure involving the building rent, electricity and water charges, stationery office payments to be made to menial and auditors, purchase of Library books, Lab Equipment and Chemicals and expenditure involving the upkeep of the institution etc.
  - c. 15% of fees collected shall be earmarked for the developmental activities of the institution.
  - d. 15% of the fees collected shall be earmarked as management's contribution towards staff benefits like gratuity, teachers provident fund, Group Insurance scheme etc.
  - e. 5% of the fees collected shall be earmarked as personal income to the Management.
8. Library should be enriched with at least 1000 books.
9. E.W.F. Scheme should be implemented to all the staff members.
10. That the list of Governing body shall be furnished to the DEO every year.
11. That the pay structure/Fee structure fixed by the governing body shall be got approved by the DEO every year.
12. That all the conditions prescribed in the G.O. and other orders which are not specified in these orders shall be complied with.
13. That the School shall not be closed without giving notice both to the parents/ DEO and competent authority at least 6 months before.
14. That the school shall be closed for permitted to be closed only from the date on which summer vacation is declared.
15. That the society shall submit proposals for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the order. However by the end of April every year, the Educational agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time.
16. Affidavit as per G.O.Ms.No. 41 Education, dated: 11.05.2006 should be submitted immediately.
17. The Management has to submit the Administrative report along with audited Accounts statement every year without fail.
18. The Management should renew the fire certificate every year.
